

## NOTICE TO ALL OWNERS OF HISTORIC VEHICLES ON CLUB REGISTRATION

### **ANNUAL SUBSCRIPTION PAYMENTS AND LOG BOOK REPLACEMENT AND UPDATES FOR 2024**

Your subscription for club membership year 2024 is now due:

- please pay **before the end of this year**,
- **if you fail to pay your subscription**, after March 1, 2024, the list of unfinancial members will be sent to Dept of Infrastructure and Transport for Club Registration determination.

Clause 3.10 of the code of practice says: "if a vehicle owner ceases to be a financial member of a recognised motor vehicle club at any time during which the vehicle is registered, the owner must not drive the vehicle or allow any other person to drive the vehicle until such time that the vehicle owner is again a financial member of a recognised motor vehicle club or has taken out standard registration."

### **ALONG WITH YOUR SUBSCRIPTION, YOUR LOG BOOK(S) WILL NEED ATTENTION**

#### **USE OF THE POSTAL SYSTEM IS PREFERRED:**

Please check the front cover for the "**Replace Log Book**" date (in red ink).

**If the date is 31/12/23**, you must apply for a new log book with your subscription payment, the following details for each book are required:-

- log book request, name, postal address, vehicle registration number and its expiry date,
- please **include the extra payments** for each log book (\$5) and return postage costs.

**If the date is 31/12/24 or 31/12/25**, post in your current log book with your subscription payment, ensuring that the following are included:-

- the log book(s) for validation,
- return postage stamped self addressed envelope.

#### **ALTERNATELY, PAID YOUR SUBSCRIPTION AND THE LOG BOOK DATES ARE 31/12/24 OR 31/12/25:**

**Validation Persons, as well as Authorised Persons** (formerly Inspectors), can "validate years 2 or 3 in your log book at any event or occasion, such as at the Kimber Run or a "Noggin and Natter" on a Friday night at the club rooms. Just present your log book, with proof of payment. They can sign, stamp and record the details. The Validation Persons are Berry Treffers, Alan Cardnell, Bev Waters and Tim Johnson.

#### **IF YOU NEED TO ATTEND THE CLUB ROOMS, THEN YOU MUST WEAR A MASK.**

This is **mandatory** and you will risk being turned away if you do not bring a mask to wear.

You are advised to **book an appointment time** with the Secretary, Berry Treffers, contact details are in the Club's magazine.

The club rooms will open from **10 am to 12 noon on every Saturday morning** from October 21 to December 16, 2023.
